

# I. <u>CALL TO ORDER</u>

Chairman Jerry Spence called to order at 9:00 a.m. the following entities: Society, Board of Directors, Accounting Education Foundation, CPE Foundation, and the Peer Assistance Foundation.

#### Introduction of 2021-2022 Chairman-elect

Ms. Testa introduced the 2021-2022 Chairman-elect, Sheila Enriquez. Ms. Enriquez gave a short acceptance speech and expressed her excitement in serving TXCPA.

# IV. TREASURER'S REPORT

Susan Roberts, Treasurer and Edie Cogdell, Chief Financial Officer delivered the treasurer's report and presented the 2021-2022 proposed member dues.

Ms. Roberts provided an overview of the investment portfolio. Ms. Cogdell presented the financial statements for the month ending December 31, 2020. The Society has a year-to-date net revenue of \$1,924,178. The unrestricted fund balance for the Society was \$8,174,431 which is 138% of net operating expenses. The CPE Foundation has a year-to-date net revenue of \$703,352. The fund balance was \$2,186,888 which is 168% of net operating expenses.

Ms. Roberts presented the proposed 2021-2022 member dues and reviewed the rationale for the recommendation to maintain the current dues schedule for 2021-2022. Ms. Roberts made the following motion which was seconded.

#### Motion:

The TXCPA Board of Directors approves the recommendation to keep the CPA dues rate flat at \$295 for fiscal year 2021-2022.

# V. STRATEGIC PLAN UPDATE

Eric Curtis with Curtis Strategy, Strategic Planning Committee Chair Ben Simiskey and Chairmanelect Jason Freeman presented updates on the Strategic Plan.

Mr. Simiskey recognized the Strategic Planning Committee and shared an overview of the planning process. Mr. Curtis highlighted the group work from the Strategic Planning Retreat that helped develop the final Strategic Plan, which was approved by the Executive Board at its August 2020 meeting. He also reviewed updates on the work done to-date on each of the goals and objectives. Mr. Freeman walked through the timeline for completion and next steps. He also shared available resources for Chapters to support their work and discussions on the Strategic Plan.

# VI. <u>STRATEGIC PLAN OBJECTIVE – 501c3 STRATEGY</u>

Mr. Curtis provided an overview of Goal 1, Objective 2 of the Strategic Plan, which focuses on consolidating the three 501c3 entities (CPE Foundation, Accounting Education Foundation and Peer Assistance Foundation) into one 501c3. The vision of the consolidation is to: ensure continuity of mission and giving; grow the level of fundraising and charitable giving; deepen and broaden value and support to members; and leverage the collective to build infrastructure and capacity.

Mr. Curtis has been working with the Governance Committee on the strategy of this objective and will continue to work with the group as it moves into implementation. Governance Committee Chair Stephen Parker presented an overview of the process and planning for the work and an outline for next steps and engagement for the initiative. The goal is to co-create the solution with all three

organizations and to build a mutually agreed upon process. Initial meetings have been held with each of the chairs of the three entities and full meetings will now be scheduled with the boards of each 501c3. Chairman Spence wrapped up with additional information and led a discussion on the thought and strategy for moving the objective forward.

# VII. OUTSTANDING ACCOUNTING EDUCATOR AWARD

Chairman Spence presented the Outstanding Accounting Educator Award to the two recipients for 2020-2021. This award is presented to Texas accounting educators who have demonstrated excellence in teaching and have distinguished themselves through active service to the accounting profession. This year's recipients are:

# IX. DIVERSITY, EQUITY, INCLUSION & BELONGING

Lisa Ong, Chair of the Diversity + Inclusion Committee and John Baines, member of the Diversity + Inclusion Committee presented updates on the work and initiatives of the committee. They reviewed the top priorities and asked attendees to help prioritize in order of importance. The priorities are:

- Increase visibility of diverse volunteer leadership;
- Cultivate inclusive leadership skills;
- Align Chapter with D+I priorities;
- Expand the CPA pipeline; and
- Identify diverse members for civic leadership.

Ms. Ong and Mr. Baines also invited members to participate in the allyship journey – to become learners, supporters and allies, whether a member of that group or not. Finally, Ms. Ong and Mr. Baines encouraged members to update their TXCPA member profiles with current demographic information to help provide complete data for the Society.

# X. <u>FUTURE OF THE PROFESSION</u>

Chairman Spence facilitated a panel discussion with the Chair of the National Association of State Board of Accountancy Carlos Barrera, Presiding Officer of the Texas State Board of Accountancy Manuel Cavazos, and AICPA Chair Tracey Golden. The panel addressed the CPA pipeline, diversity and inclusion, deregulation, and the CPA Evolution.

# XI. WRAP UP

Chairman Spence reminded members of the virtual legislative visits scheduled throughout the week and the deadline for the Call for Volunteers, which closes February 3. He also stated a decision has not been made on whether the next Board meeting will be held in person or virtually. The meeting is currently scheduled for June 25-26, 20201 in Park City, UT. Staff is gathering additional information and may reach out with a survey to the Board to help evaluate options.
