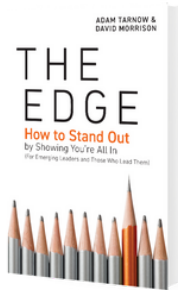
LEADERSHIP DEVELOPMENT ACADEMY
